The Food Stamp and Medical Employer Tracking Report Second Year Report For the time period of December 2008 through November 2009 January 12, 2010

Background

During Oregon's 2007 Legislative session a bill was submitted that would have required tracking employers of Oregon Department of Human Services (DHS) clients that were receiving Food Stamps or medical assistance.

Ultimately the bill did not pass and the specific tracking requirement did not become law. As a response to legislative concerns DHS agreed to track the names of employers for clients who began employment while receiving Food Stamp benefits or Children Adults and Family (CAF) Self Sufficiency and Seniors and People with Disabilities (SPD) medical program benefits. The report resulting from that initial tracking effort was made on January 13th, 2009. This is the second and last report of findings of the Food Stamp and Medical Employer Tracking Project.

Data Collection Methods and Constraints


DHS added a field to the Client Index (CI) screen that would allow staff to enter the names of up to 13 employers per person for clients receiving Food Stamp or medical program benefits. Staff responsible for determining eligibility for these programs were instructed to enter all recorded employers for clients applying for and participating in these programs.

During the analysis a number of data collection constraints were noted:


- Employer data was not linked to any other source such as Employment Department wage matches or to any other DHS income source.
- Employer information had to be manually entered and there is no edit that would require a staff person to enter the data. As a result some employer data may not have been entered into the system.
- There was no date associated with the entry of employer data. This limited the ability to associate employer information with the receipt of the benefits at a specific point in time.
- Employer names were entered differently and as such some employers may be reflected under two different names. Every effort was made to cleanse employer names and modify or delete invalid records.
- Employers are listed only if the client received Food Stamps, Medical or both from December 2008 through November 2009 and the employment episode was new.
 However, there is no way to tell if the client was getting benefits on the day when their employment was recorded or what the benefit configuration was.
- The level or extent of employer benefits and when they become available is not known.
- The size of the sample was robust enough to ensure a large degree of confidence in the placement of the top 50 employers. The order of the employers in the list changed slightly from last year, however, as projected, <u>almost</u> all of the top 50 employers from last year remained within the top 50 this year.

Results


- There were 29,369 clients with recorded employers on the CI screen with employment episodes who received Food Stamp benefits, CAF Self Sufficiency or SPD medical benefits at some time during the period December 1, 2008 through November 30, 2009.
- Of the 29,369 clients with CI recorded employers, 13.3% or 3,922 received medical only benefits, 28.9% or 8,475 received both medical and food stamp benefits and 57.8% or 16,972 received food stamp benefits only.



 A small percentage, (5.7%) of employed clients had more than one employer documented on CI.



• The top 15 employers made up (11.3%) of total employer records, (3,541) of 31,229.
